SECTION 4 FIRST AID MEASURES

Description of necessary first aid measures

Inhalation:	Remove victim from exposure if safe to do so. If rapid recovery does not occur, transport to nearest medical facility for additional treatment
Skin Contact:	If skin contact occurs, wash skin thoroughly with water and follow by washing with soap if available.
Eye Contact:	If in eyes, hold eyes open, flood with water for at least 15 minutes. If persistent irritation occurs, seek medical attention
Ingestion:	If swallowed, do NOT induce vomiting. Wash out mouth with water

Inhalation:	May cause irritation to respiratory system - coughing and difficulty breathing

SECTION 6 ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Avoid contact with spilled or released material. Shut off leaks, if possible without personal risks. Isolate hazard area and deny entry to unnecessary or unprotected personnel. Remove all sources of ignition in the surrounding area.

Environmental precautions

Use appropriate containment to avoid environmental contamination. Prevent from spreading and entering waterways using sand, earth or other appropriate barriers.

Methods and materials for containment and cleaning up

For spills, transfer by appropriate means to a labelled, sealable container for product recovery or safe disposal. Allow any residues to evaporate or use an appropriate absorbent material and dispose of safely. Do not flush residues with water. Dispose of safely in accordance with regional regulations.
